Background

UnionPay International (UPI) announces the Settlement Holiday Schedule for the Year 2024. All UPI Members and Special Participants are expected to make proper arrangements accordingly.

Note: The time indicated herein is in Beijing Time (GMT+8) in the 24-hour format.

Arrangements

1. General Settlement Holiday Schedule (for Acquirers)

Unless otherwise specified, UPI will not settle with UnionPay Card Acquirers on the following settlement holidays of the Chinese Mainland:

Note: When UPI uses the settlement accounts in Hong Kong to settle with Acquirers based on special settlement arrangement, both the settlement holidays in the Chinese Mainland and Hong Kong will apply. 2. Specific Currency Settlement Holiday Schedule (for Issuers)

For Issuers that settle in currencies other than the Chinese Yuan (CNY), the settlements should not be conducted on the public holidays announced by the local government, central bank, or settlement agent banks. The issuing settlements in those currencies should be conducted on their local working days.

For Issuers that settle in CNY, the settlement will not be conducted on the public holidays announced by the Chinese government. Issuers may refer to the General Settlement Holiday Schedule specified above for detailed holiday information. Besides, according to the government announcement, the following weekends are considered as working days when CNY settlement will be conducted.
